

**Northwest Federal Credit Union**  
**Commanders Game Tickets Sweepstakes - Official Rules**

1. **Sponsor:** Northwest Federal Credit Union (or “Credit Union”) is the sole sponsor of the drawing. This drawing is not sponsored or managed by the Pro-Football, LLC d/b/a Washington Commanders (“Team”) or the National Football League.
2. **Prize:** One drawing will be held on Tuesday, December 19, 2023. Four winners will be drawn. The first two winners will each receive two tickets to club level seats for the Washington Commanders home game on December 31, 2023 plus one parking pass. The next two winners will each receive two tickets to club level seats for the Washington Commanders home game on January 7, 2024 plus one parking pass. Winners may not substitute prize nor substitute ticket dates.
3. **Eligibility: No purchase or obligation necessary to participate and win.** All participants must be 18 years of age or older at time of Contest Period start date, must be a legal resident of one of the fifty states of the United States or the District of Columbia, and be members in good standing of Northwest Federal Credit Union (as determined by sponsor in its sole discretion). Winners of prior Credit Union Commanders Game Tickets Sweepstakes are ineligible. Employees of the Credit Union and members of their household are not eligible to register for the contest. Participants must be subscribed to Credit Union marketing emails or calls at the time of Contest Period end date to be eligible to win and receive prize. Contest void where prohibited by law.
4. **Contest Period:** The contest will begin at 12:00 a.m. EST on November 18, 2023 and will end at 11:59 p.m. EST on December 18, 2023 (“Contest Period”).
5. **How To Enter the Contest:** Use your Northwest Federal Credit Union debit card or Northwest Federal Credit Union credit card for 10 eligible purchase transactions within the Contest Period. For each 10 eligible transactions, you will receive one entry. There is a maximum of 50 entries per member. Eligible debit card and credit card transactions are aggregated separately. For example, five eligible debit card transactions and five eligible credit card transactions will not qualify for entry. Eligible purchase transactions must post to the account within Contest Period. Eligible purchase transactions conducted by authorized users or joint accountholders count toward entries for the primary accountholder.

Account adjustment transactions/returns, cash advances, balance transfers, payment of late fees or over-limit fees are not eligible transactions for entry. Business account debit and credit cards are excluded from contest entry.

6. **NO PURCHASE NECESSARY:** To enter without use of a Northwest Federal Credit Union credit or debit card, hand print your name, street address, city, state, and zip code,

and your phone number and email address on a 3x5 index card and mail in a sealed envelope to:

Mailed entries must be received by Northwest Federal Credit Union no later than December 18, 2023. Maximum 50 entries per member.

Contest sponsor will not be responsible for incomplete, lost, late, misdirected or illegible entries or for failure to receive entries. All entries become property of Northwest Federal Credit Union and none will be returned. Any questions regarding the number of entries submitted shall be determined by the contest sponsor in its sole discretion, and Northwest Federal Credit Union reserves the right to disqualify any entries by persons determined to be tampering with, violating, or abusing any aspect of the contest.

7. **Contest Entry Requirements:** In the event Northwest Federal Credit Union, in its sole discretion, determines that any entry does not comply with these Official Rules or does not otherwise comply with regulatory guidelines, Northwest Federal Credit Union reserves the right to disqualify the entry.
8. **Determining the Winner:** A Northwest Federal Credit Union employee will randomly select four Prize Winners from all entries received on December 19, 2023. You do not have to be present to win.

The prize winner will be notified by phone or email address on record. The winner must respond to Northwest Federal Credit Union within two days of notification to receive the prize. Failure of the winner to respond within the required time period will result in disqualification of winner, forfeiture of his or her interest in all prizes, and selection of a substitute winner. Winners may waive their right to receive prizes. Prizes are non-assignable and nontransferable. No substitutions allowed by winner. Prizes and individual components of prize packages are subject to availability and Northwest Federal Credit Union reserves the right to substitute prizes of equal or greater value. Prize will be delivered electronically and will include necessary instructions for accessing tickets. Winner may be required to download smartphone applications to redeem prize.

9. **Participation.** By participating, entrants agree to be bound by these Official Rules and the decisions of the contest.

By accepting the prize, winner agrees as follows:

I confirm that I have complied with all eligibility requirements as required by the Credit Union as provided in the contest rules. I am a U.S. resident, and was at least eighteen (18) years of age at the time of Contest Period start date. I further confirm that I am not an employee of the Credit Union and do not live in the same household as an employee of the Credit Union.

I acknowledge that I am solely responsible for all federal, state, and local taxes due as a winner of the contest. I understand that the Credit Union cannot and has not provided advice regarding potential taxes that may be due, and recognize that I may wish to seek independent advice to determine the full extent of my tax liability under state and federal laws and regulations.

I acknowledge that I am responsible for any other expenses that may become due as a result of my winning the prize.

I understand and agree that the Credit Union, Team, WFI Stadium LLC, Scoreboard HoldCo LLC, Scoreboard HoldCo II LLC, NFL Ventures, Inc., NFL Ventures, L.P., NFL Properties LLC, NFL Enterprises LLC, and each of their respective subsidiaries, affiliates, shareholders, officers, directors, agents, representative, and employees (collectively, "Released Parties") are not responsible for, and make no warranty, representation, or guarantee, express or implied, regarding the prize and its quality, merchantability, fitness for a particular purpose, or condition.

I agree to indemnify and to hold harmless the Released Parties from any loss, claims or damages, including reasonable attorney's fees, resulting from or relating to, directly or indirectly, my participation in the contest and winning the contest prize.

I grant to the Credit Union, the right to use, re-use, reproduce, broadcast, publish, edit or prepare derivative works, in whole or in part, individually or in conjunction with other information or photographs, on any of Credit Unions' web sites, social media, YouTube or in any other public or private medium and for any purpose whatsoever, including (but not limited to) education, promotion, advertising, videos and other marketing (the "Permitted Uses") my name, likeness, images, or any statements in connection therewith if Credit Union so chooses.

I hereby waive any right that I may have to inspect or approve the finished product or products, advertising copy or other matter that may be used in connection therewith or the use to which it may be applied.

I hereby release and discharge the Released Parties from any and all claims and demands I may now or hereafter have arising out of or in connection with the Permitted Uses of the Profile, including, without limitation, any and all claims for the

right of privacy, publicity, libel or slander and any and all claims and/or demands for royalties associated therewith.
